In Beloved Community's fourth year we supported 124 organizations with ongoing facilitations, trained 556 organizational leaders in diversity, equity and inclusion practices. We celebrated the following impact and milestones: 1) Equity Audit Tool Suite: In FY21, 223 organizations completed the Equity Audit and 2,766 employees completed the Equity Lens Map. Respondents represented all three target organizational types: nonprofits/colleges/universities (108), k-12 schools (93), and for profit businesses (22). Respondents employed 48209 to 285536 full-time staff. 2) Capacity-building services: In FY21 Beloved Community provided equity training for 556 organization leaders via Deep Dive engagements including workshop facilitation, leadership coaching, equity work plan development, and train-the trainer support. 3) Communities of practice: Equity in School Cohort in Indianapolis supporting 5 charter and innovation school founders in the development of their equity plans. Equity in Schools Cohort in New Orleans supporting 7 schools and education nonprofits. Equity in Schools Cohort in Indianapolis supporting 7 charter and innovation school leadership teams.
